Syria chemical weapons: Organization for the Prohibition of Chemical Weapons (OPCW) plea for short ceasefires – BBC (UK), 14 October 2013

Ahmet Uzumcu, of the OPCW, called for local, short-term ceasefires to allow experts to work. Syria officially joins the Chemical Weapons Convention on Monday, 14 October 2013. Meanwhile, three of the six Red Cross workers who were kidnapped on Sunday, 13 October 2013, have been freed, the ICRC has said. A Syrian Red Crescent volunteer who was with them has also been released, the group added. All those freed are reported to be unharmed.

Greek Foreign Minister in Tirana visit Albania - Balkan Web (Albania), 14 October 2013

The Greek Foreign Minister (FM), Evangelos Venizelos, was in Tirana for a round of meetings with the Albanian top officials, according to the electronic media reports. On the eve of the Greek FM's visit to Tirana, the Party for Justice, Integration and Unity (PJIU) announced that the resolution on the Cham question that was passed by the Albanian Assembly in 2004, has been published in the Official Journal, on 20 June. They urged the government to abide by the resolution in all their dealings with the Hellenic authorities.

Iran's negotiators are sitting down Tuesday, 15 October 2013, in Geneva with six world powers for talks aimed at curbing its nuclear ambitions, amid a spirit of new optimism since President Hassan Rouhani took office this summer. Ahead of the meeting, Iranian Foreign Minister, Javad Zarif, said he hoped that together Iran and the West would be able to work out a "roadmap" toward a final resolution by Wednesday, 16 October 2013.

Vote for prisoners: Supreme Court rejects appeal by two inmates – The Guardian (UK), 16 October 2013

Two convicted murderers who argued that European Union law gave them the right to vote in UK elections have had their appeals dismissed by the Supreme Court at Westminster. The European court human of rights in Strasbourg has already ruled that Britain's ban that denies all those serving any sentence the ability to vote is illegal. A parliamentary committee is currently considering the political options - whether to enforce those rulings or defy ECHR judges. The Supreme Court judges acknowledged that Strasbourg has stated that the ban on prisoner voting is incompatible with human rights but observed that since the declaration has already been made there was no point in repeating it.

European Commission (EC) recommends candidate status for Albania, but the EC puts 5 new conditions - Top Channel TV (Albania), 16 October 2013

The European Commission (EC) published its annual progress report on Albania and other countries assessing how far countries aspiring to full accession have come in bringing their laws and behaviour into line with EU standards. "In view of Albania having achieved the necessary progress, the Commission recommends that the Council should grant Albania the status of a candidate country on the understanding that Albania continues to take action in the fight against organised crime and corruption," reads a document titled "Communication from the Commission to the European Parliament and the Council. Enlargement strategy and main challenges 2013-2014". The Commission said that Albania needs to meet the following key priorities for the opening of accession negotiations: 1. continue to implement public administration reform with a view to enhancing professionalism and de-politicization of public administration; 2. take further action to reinforce the independence, efficiency and accountability of judicial institutions; 3. make further determined efforts in the fight against corruption, including towards establishing a solid track record of proactive investigations, prosecutions and convictions; 4. make further determined efforts in the fight against organised crime, including towards establishing a solid track record of proactive investigations, prosecutions and convictions; 5. take effective measures to reinforce the protection of human rights, including of Roma, and anti-discrimination policies, as well as implement property rights.

Russia's Alexei Navalny's sentence suspended on appeal – BBC (UK), 16 October 2013

A Russian appeals court has upheld opposition leader Alexei Navalny's conviction for embezzlement, but suspended his jail sentence, allowing him to go free. However, his conviction is likely to prevent him running in the next presidential election. Navalny was sentenced to five years in July but released pending the appeal. He has always denied the charges, which relate to his time as an adviser to the governor of the Kirov region.
